Dear John:

I am pleased to nominate Jennifer Jones with the Washington, DC office of Goulston & Storrs, P.C. for membership in the American College of Real Estate Lawyers.

Jennifer and I have worked together in support of the Council on Legal Education Opportunity (CLEO), the signature educational non-profit organization in the U.S. (founded in 1968), whose mission is to expand opportunities for underrepresented students to attend and succeed in law school. We first met when Jennifer joined the CLEO advisory board in 2023 and have subsequently worked together on the CLEO Board, when Jennifer joined me as a member of the CLEO Board of Directors in 2024.

(for which local counsel has been involved), Jennifer has been involved in every aspect of this project, and her legal work and leadership was critical to its success. The project currently involves, among other things, the preparation of (1) declaration of easements, restrictive covenants and other agreements concerning, among other things, common area costs, restrictions and other items encumbering the project, (2) two anchor leases (one with a high end gym and one with a grocery store) for two of the buildings in the projected, and (3) a master lease form to be used between each building owner and the owner of each parking garage building to permit shared parking for use by customers and residents of the buildings. Once the anchor leases and master lease form is completed, financing, additional leasing and other real estate legal work will follow on this project for several years to come.

In addition to her Gateway Companies' experience, Jennifer has represented major clients in a wide variety of commercial real estate transactions including, among others, WS Development, Boston Properties, Home Asset, Inc. (d/b/a NewQuest Properties), King Street, Affinius Capital, Atlas Capital, Walton Street Capital and Nuveen. Most recently, she represented: (i) Nuveen in a multi-floor office lease with the United Nations, (ii) WS Development in numerous retail leases for retail and mixed-use projects in various states, including, among others, an Aldi lease for a retail project in Pennsylvania, (iii) Home Asset, Inc.
