As a member of the planning committee, I worked with other committee members to brainstorm topics and presenters. Among the selected topics was the expansion of county-level rights of first refusal related to the same of multi-family properties. I worked with two other presenters to address this topic in three different counties—with my presentation focused on Prince George's County, Maryland. At the time, Prince Georges' County was in the process of developing its approach to the ROFR law and assignment to designated developers. My presentation outlined the legal requirements, trends, and practice tips.

Retail Recovery - Reimagining For The New Future, Spring 2021, Real estate professionals from Jones Lang LaSalle and Ballard Spahr discuss current conditions on the ground in each asset class of malls, grocery-anchored shopping centers and big box centers. Our panelists covered issues facing owners of distressed properties, from re-purposing underperforming assets to preparing for a post-pandemic retail climate.

COVID-19 and Real Estate Transactions: Where Are We and Where Do We Go From Here?, Maryland State Bar Association, Advanced Real Property Institute, Legal Excellence Week, November 9-13, 2020 – Presenter and Planner – I was a member of the planning committee for this annual continuing legal

This included a detailed review of state-specific laws related to condominium creation, subdivision (including minor subdivision), and air-rights. Ongoing operational issues were also discussed, including shared governance, phased development, and cost allocation. Attendees were particularly interested to discuss potential strategies of long-term projects as it related to Maryland's condominium laws related to phased annexation.

Structuring Complex Easement Agreements in Commercial Real Estate Deals, Strafford (September 18, 2018) – Presenter – This program addressed the purpose of easements in a variety of real estate transactions, including mixed-use developments, retail projects, condominiums, air rights developments, as well as basic components of easements and the role of easements in the life cycle of a project. Various approaches to ongoing operational easement matters were also discussed, including maintenance and cost allocation, project governance, density and development rights, and multi-phase projects. Key negotiations and drafting issues were also discussed.
