As President of ACMA this past year Andrew restructured the leadership of the Program Committee, expanding CLE programming to include the Spring Meeting and webinars.

Andrew cultivates others and is a great mentor. At RPTE, he was particularly adept at identifying potential leaders, especially younger ones, really early on, and in finding committee, speaking and other roles within RPTE which would engage these leaders and help them advance more quickly within the organization. As Chair of RPTE and President of ACMA Andrew made sure both organizations contributed to the development of new model rules and commented on important legislation affecting the real estate bar.

Andrew is strategic. He oversaw significant long term planning efforts for both RPTE and ACMA. At ACMA he has spearheaded a highly successful ongoing effort to recruit younger members. Andrew has also been strategic with his leadership roles in the profession, which have been serial so he could give his all to the organization. As he winds up his year as Immediate Past President of ACMA he will be in a perfect position to contribute to ACREL as a future Fellow. Active participation is in his DNA.

Andrew is equally involved as a leader in his communities. Whether serving his hometown of Alexandria, Virginia, The American University of Rome or his Alma Mater he has decades of experience as a board member and civic leader in addition to his pro bono service.
