DESCRIPTION OF CURRENT PRACTICE

I have a broad based commercial real estate practice focusing on net lease transactions, real estate joint ventures, development of commercial properties, leasing, and acquisitions and dispositions.

Historically, my practice has been split evenly among all of the areas identified above. More recently, my practice has had a greater focus on net-lease transactions, the disposition and redevelopment of office buildings and real estate joint ventures, particularly in the single-family build-to-rent market. The breakdown of my practice over the past two years has been net lease transactions (40%), joint venture and related work (25%); acquisitions and dispositions of commercial properties, including office buildings and industrial facilities (20%); and tenant side commercial leasing focused on office and industrial facilities (15%). Previously, I spent a significant portion of time assisting purchasers of distressed debt and a national retailer in its leasing activity across the country. Representative experience is below.

#### **Net Lease Transactions**
