It is with great pleasure that I nominate Allen Wheeler of the Minneapolis office of Faegre Drinker Biddle & Reath LLP for membership in the American College of Real Estate Lawyers. I have reviewed the College's Guidelines for Regular Member Selection and certify that Mr. Winner satisfies the criteria for selection to the College as set forth in the Guidelines.

I have known Mr. Wheeler since around 2010 during my tenure in the Real Estate Workgroup of the Target Corporation Legal Department. (I left Target in April 2015.)
