Relatively few law firm lawyers hold the highest leadership positions in NAIOP, and Scott's leadership activities in that organization have been very positive for our profession

Because he is one of the top lawyers in the country in his niche real estate practice area, because he is a thought leader among lawyers and other real estate professionals, and because he has earned the respect of prominent real estate professionals (lawyers and nonlawyers) at the national, state and local levels, Scott will be an excellent addition to ACREL. He will not only live up to the standards of an ACREL Fellow, but he will also make our organization stronger and enhance our brand.

I am able to certify that Scott satisfies the criteria for selection to the College as set forth in Section 4 of the Guidelines for Regular Member Selection.
