Through collaboration with colleagues and others in the economic development industry, I founded the Vorys Economic Development Incentives Conference ten years ago, and it has become the largest such annual conference in the world.

In 2022, I founded Vista Site Selection, LLC, an ancillary business of the law firm currently composed of seven professionals based primarily in Texas who focus their work on finding optimal sites for businesses to locate and grow. I have served as board chair for Vista since its founding.
